NOTIFICATION

A State Advisory Board for Correctional Administration is set up with the following objectives under Chapter III of Rule 5 of the Pondicherry Prison Rules 1969:-

- i) To advise regarding prevention, control and treatment of delinquency and crime.
- ii) To suggest ways and means for improvement levels of co-ordination between Administration of Justice, Police Administration and Jail Administration.
- iii) To suggest measures for creating social consciousness for the rehabilitation of offenders.
- iv) To suggest ways and means for the rehabilitation of offenders.

2. In this regard, the Lieutenant Governor of Puducherry hereby appoints the following official members for the constitution of the State Advisory Board for Correctional Administration as per the Rule 6 of the Pondicherry Prison Rule 1969:-
